INVITATION TO BID
SALE OF CONDEMNED ITEMS AS IS WHERE IS BASIS**

1. The Director National Institute of Cancer Prevention And Research, Plot No. I-7, Sec-39, Noida-201301, invites Sealed Bids for sale of Condemned Vehicles/Laboratory Equipments/items, used furniture, & Misc. Stores **(as per Schedule of Sale enclosed at Annexure-I)**. The bidders may go through the Terms and Conditions carefully. In case any bidder fails to follow any one or more of these conditions, their offer shall be summarily rejected.
2. The prospective **bidders may satisfy themselves** about the quantity & condition of the items physically available by visiting the site **before bidding between 03:00 to 05:00 PM on 26/07/2019 and 27/07/2019**. The Director National Institute of Cancer Prevention And Research, reserves the right to cancel the bidding process any time, or, reject any or all the Bids without assigning any reason.
3. The Bids should be made in one sealed Envelope which should be clearly marked as **“Bid for unserviceable items & “Date of Opening”**.
4. **Last Date of Submission** – Last date of Receipt of Sealed Bid Documents at NICPR, Noida is **29/07/2019** by **1.00P.M.** only by hand (at NICPR Store Section). Bids by E-mail/Fax/courier/Post will not be accepted. “Late Bids”, for any reason whatsoever, will not be entertained/ taken into account, without assigning any reason thereof.
5. **Date & Time of Opening** – The Bids will be opened by the Nominated Committee on same day i.e., **29/07/2019** at **2.30P.M.**, at 2nd Floor, Board Room Hall. The Bidders are requested to be present during opening of the Bids along with their ID Proof.
6. **Acceptance of Offer** – The Bids accompanied with above conditions, will only be considered. For calculation of Highest (H-1) responsive Bidder, the total value excluding GST quoted for **Payment to NICPR, Noida,** by the successful Bidder to the Concerned Authorities/parties, will be taken into consideration. Further acceptance of H-1 Bid will be subjected to it being **equal or higher than** the reserve price. In case of any tie in Bid rates/value offered, negotiation will be held.
7. **EMD:** - Each bid must contain Bank Draft of Rs. 30,000/- (Rupees Thirty Thousand Only) as Refundable EMD from any nationalized bank drawn in favor of **Director, NICPR** Payable at **Noida**. Bids without EMD will be rejected.
8. Each tender must contain the Total value excluding GST not only in figures but also in words (in English). In case of any Clerical/Typing error, value written in “words” will only be considered for assessing the H-1 Bidder and subsequent process.

9. Fax/E-mail/Courier/Conditional Bids will not be accepted.
10. Other Terms & Condition of Sale are attached at Annexure-II.
11. Bidders need to quote separate rates for Part A, Part B and Part C of Annexure-I.
12. Please use Annexure-I for quoting rates.
13. The H1 bidder has to submit 100% of bid value Plus GST@18% extra in form of D.D/NEFT/RTGS in favor of Director, NICPR within 02 (Two) working days after finalization of bid by the committee.
14. Each bidder must enclose their **PAN, GST and Aadhar Number** along with bid.
15. The H-1 bidders for Vehicles have to deposit additional amount of Rs. 15,000/- for each Vehicle (refundable) in form of Bank Draft in F/O Director, NICPR, Payable at Noida which will be refunded after receipt of piece of chassis No. & Engine No. Plate. Original R.C. will not be given to the bidder.
16. At any level list of items, quantity etc. will not be given to the successful bidder. Scrap/stores will be sold **“As is Where is basis”**.

If at any stage it is noted that the Bid offered does not meet the NICPR conditions, The Director, NICPR reserves the right to take any decision including cancellation of the Bid process/acceptance of offer etc. Any dispute in this regard concerning any Terms and Conditions of the Bid documents and/or the sale of items, will be subject to Noida Jurisdiction only.
3. No Bidder shall be allowed at any time on any ground whatsoever, to revise or modify the rates quoted by him, nor he will be allowed to withdraw the offer quoted.
4. **Balance Payment** : Balance amount of the accepted Bid is to be paid by the successful Bidder within 02 (Two) Days from the Date of “Award of work” in the form of a A/c Payee Demand Draft from any Nationalized Bank or NEFT/RTGS, in favour of “Director, NICPR” and payable at Noida. Failure to do so may result in forfeiture of EMD Rs 30,000 and cancellation of award of work.
5. All goods mentioned in the “Award of work” shall be removed by the Bidder at its own cost and risk from NICPR premises **on or before 31/07/2019**. While lifting of stores, any damage to Institute premises shall be recovered from the Bidder.
6. **All the pages of tender document and Terms & Conditions are to be duly signed and sealed by the Vendor and returned/attached** with the Bid, failing which the Bid will be summarily rejected.
