- 3. Technical Bids and Price Bids (as per Schedule specifications / details of Requirement at Annexure-I) should be made/sealed separately and put together in an Envelope which should be clearly marked as "Tender for (items)" & "Date of Opening". Technical Bid should accompany EMD and Line-wise confirmation of the proposed Specifications on Vendor's Letter Head.
- **Last Date of Submission** Last date of Receipt of Sealed Tender Documents at NICPR, Noida is <u>31-03-2017</u> by <u>4.00P.M.</u> by Post or by Hand (at NICPR Reception). Tenders by E-mail/Fax will not be accepted. "Late Tenders", for any reason whatsoever, will not be entertained/ taken into account, without assigning any reason thereof.
- 5. <u>Date & Time of Opening</u> Technical Bids will be opened by the Purchase Committee on <u>06-04-2017</u> at <u>2.30P.M.</u>, at 2nd Floor, Board Room. The Tenderers or their authorized representatives are requested to be present during opening of Technical Bids. Price Bids of only those Tenderers whose Technical Bids are found suitable/acceptable subsequently by the Technical Screening Committee of NICPR, Noida, will be opened later on. Date and Time of the same will be intimated to the applicable Tenderers in <u>advance by E-mail</u>, so as to enable them to be present at the Time of opening of their Price Bids.
- **Acceptance of Offer/Tender** Price Bids of only technically suitable/acceptable Offers/Vendors, as mentioned above, will only be opened. For calculation of Lowest (L-1) responsive vendor, the total value quoted for **Free of Cost Delivery at NICPR, Noida** of each item separately will be taken into consideration and L-1 worked out for **each chair** separately. Purchase Order will be placed accordingly.

- 7. Each tender must contain the Rate not only in figures but also in words. In case of any Clerical/Typing error, value written in "words" will only be considered for assessing the L-1 Bidder and subsequent process, though the Director NICPR reserves the right not to accept any Tender only on the L-1 (lowest) criteria.
- **8.** Fax/E-mail/Conditional tender will not be accepted.

- Should be a body contoured electrically operated dental chair unit with two programs, zero & gargle position.
- Should have a ceramic spittoon & cup filler with auto water system.
- Should have a halogen light with two intensity: high & low.
- Should have vertical & horizontally movable instruments arms with pneumatic locking system.
- Should have an instrument tray & adjustable headset
- Should have a multifunctional foot control
- Should have an air rotor control box
- Should have a x-ray viewer with white light
- Should have one pneumatic suction
- Should have one three-way syringe for assistant side
- Should have a doctor's stool with pneumatic piston for height adjustment
- Should have a dental oil free compressor 0.75hp.

OTHER TERMS AND CONDITIONS OF SUPPLY

- 1. Tender should be preferably, typewritten and every correction in the tender should invariably be signed by the Tenderer, failing which, the tender is liable to be rejected.
- 2. The Tenderer should ensure that the items offered fully meets the Specifications laid down by the Institute. If at any stage (even after placement of order/supply etc.) it is noted that the item offered does not meet the specifications, The Director, NICPR reserves the right to take any decision including cancellation of the Tender/offer/Purchase Order etc. with forfeiture of EMD/SD/PBG as the case may be. Any dispute in this regard concerning any Terms and Conditions of the Tender and/or the supply of item, will be subject to Noida Jurisdiction only.
- 3. No Tenderer shall be allowed at any time on any ground whatsoever, to revise or modify the rates quoted by him. The Tenderer will not be allowed to withdraw the offer quoted. In the event of withdrawal, the EMD tendered shall be forfeited.
- 4. Increased statutory levies and duties, over and above the rates quoted in the Tender, will be borne by the Tenderer for supplies after the originally permitted Date of Supply in the Purchase Order. The Institute shall not extend validity period for this reason and it will not bind the Institute for supplies beyond the date specified in the Purchase Order.
- **Inspection and Acceptance of Items** Acceptance process of the item(s) supplied will be considered complete only after satisfactory Installation and duly Certified as such by the User and Countersigned by the Director NICPR, Noida.
- **EMD** of Rs. 10,000/- in the form of a Crossed Bank Draft in favor of "The Director, NICPR", payable at "Noida" to accompany the Bid. The Tender without the EMD will be rejected summarily. No interest is payable on EMD which should be valid for at least 90 Days. EMD of un-successful Bidders will be released on finalization of Purchase Order.
- 7. Payment 100% Payment for the Items will be made after Acceptance as per Para 5 above, on submission of the Invoice, and Acceptance Certificate (Para-6 above).
- **8.** <u>Warrantee:</u> The Vendor is to provide a warrantee of at least three years from the date of Installation & Commissioning, at NICPR, Noida.
- **9.** If the tenderer fails to execute the Purchase Order within the specified delivery date or, as mutually agreed to in writing, the Order will be cancelled and EMD will be forfeited.
- 10. All damaged or unapproved goods shall be removed by the vendor at its own cost and risk. Any incidental expenses incurred by the Institute thereon shall be recovered from the vendor. Defective parts in the equipment, if found, before installation and during the warranty period, shall be replaced within 30 days of date of intimation from the NICPR, at the cost and risk of supplier, including customs duty, etc.
